## Discussion with Management on our list of issues

We vide our Circular No. 40/XVI/2018 dated 27.03.2018 informed you about Management's invitation to our Federation for discussion on 18.04.2018 on our list of issues. In that regard, we requested all our Central Committee Members for extending their contributions in framing the list of issue. We also requested them to send their suggestion for issue(s) with justification positively within 6<sup>th</sup> April 2018. But, till now we have not received such suggestion from any of our CC Members. We once again request you to ponder over the matter and put forward your concrete suggestion so that a collective approach can be made towards framing the issues.

Management, in their letter restricted the number of participants in the discussion to 4 (four) including the General Secretary and wanted us to raise only individual issues. We vehemently opposed such approach of restricting our Federation. We categorically told them as they were restricting number of Federation's participants in the meeting, the Federation would also take care to send only a few participants by its units when the MD&CEO would hold staff meet in various States. Finally they agreed for 7 (seven) participants including the General Secretary. On their contention of individual issues, we made it clear to them that in an earlier occasion also the Management put such restriction and ultimately had to withdraw the same in the face of steep opposition from Federation. We reminded them that after the central squatting of 21st February 2014 Management informed us that they were prepared to discuss "employees' issues" with the Federation. Then, they did not insist on raising individual issues.

Com. Debadatta Mohanty, one of our Deputy General Secretaries informed us that owing to serious illness of his father he was not in a position to leave his home and gave his personal suggestion to include Com. P.K. Sarangi in the team for this discussion only. His proposal was placed before the President and Working

President. Both President and Working President have approved the proposal. Accordingly, besides the undersigned the following comrades will represent the Federation in the discussion:
