## Our efforts for payment of overtime allowance in terms of Bipartite <u>Settlement during demonetization drive</u>

Through our Circular No.28/XVI/2017 dated 28<sup>th</sup> November 2017, we informed you about the letter of the Conciliation Officer to the MD & CEO dated 20th November 2017 in response to our rejoinder dated 17th November 2017 to Management's submission dated 2nd November 2017. The Conciliation Officer, in her letter, requested the MD & CEO for informing Management's decision within 30<sup>th</sup> November 2017 in regard to payment of overtime allowance. Today, the undersigned has been informed that the reminder has been sent to the MD. Copies of Management's letter and reminder of the Conciliation Officer are being sent herewith in the attachment.

We would request you for mass circulation of these correspondences from which the employees may come to know about the sincerity of the Federation in achieving the issue of overtime allowance in favour of them.
