## Payment of overtime allowance in terms of Bipartite Settlement

You are aware of the development on the Industrial Dispute raised by us that for breaching the provision of Bipartite Settlement for payment of overtime allowance, show cause notice was issued to the MD & CEO by the ALC(C), Kolkata. General Manager (HR) replied to the show cause notice, but in Law such reply has to be given by the accused himself. Accordingly, the MD & CEO replied on 16.02.2018, a copy of which is enclosed for your information. In any case, in the face of show cause notice, the Management undertook an exercise for the period from 20.11.2016 to 31.12.2016. As our clear demand is for payment of appropriate overtime allowance i.e. for all the days in which the employees had to work overtime during demonetization exercise, we addressed a letter to the MD & CEO on 17.02.2018 reminding him that payment of overtime allowance has to made for the following dates and & period otherwise that will not be acceptable to us.

From 9<sup>th</sup> to 11<sup>th</sup> November 2016 12<sup>th</sup> and 13<sup>th</sup> November 2016 beyond 6 ½ hours of working From 20<sup>th</sup> November to 31<sup>st</sup> December 2016

Full text of our letter was circulated through our previous circular dated 22.02.2018. On the basis of our said letter, the ALC(C) took up the matter once again with the MD & CEO vide their letter dated 16.03.2018, the copy of the same is also enclosed for your information. 12<sup>th</sup> April 2018 has been fixed for conciliation.

We wish that each and every members of our organisation and also the members of other organizations should be aware of all these developments.
