Com. S.B. Menon presided over the meeting. The meeting condoled the unfortunate death on account of Corona infection of the employees Union Bank of India in particular and those of the banking industry in general. The meeting conveyed deep condolences to the family of these comrades.

As proposed by Com. S.B. Menon and supported by rest of the organizations, the platform of the united movement has been named as, "JOINT FORUM OF UNION BANK UNIONS". Other details of the Forum have been decided to be finalized in the first ever physical meeting proposed to be held in Kolkata after restoration of normalcy.

All the participants expressed deep anguish over the anti-workmen and discriminatory attitude of the Management of Union Bank of India in not harmonizing the best of 3 staff benefits and releasing them from April 2020 itself, over non-availability of Request Transfer module in Union Parivar making them unable to submit fresh application and see the update diarised number of their already submitted applications and over a move to close a number of branches in the name of rationalization and over some other issues also.

After discussion, it is decided that to start with, a Memorandum highlighting the formation of the JOINT FORUM and the issues of best of the staff benefits (for existing as well as retired employees), Request Transfer and branch closure will be submitted to the Management, according to the availability of MD & CEO / ED / CGM (HR), within the next week. It is also decided that after submission of Memorandum a Circular will be issued by the Forum, however, in the meantime each of the participant unions will circulate among the employees about formation of the Forum in their own way so that the employees of amalgamated

entity of Union Bank of India can come to know about this effort for united movement and irrespective of their union affiliation can extend their support and co-operation towards the movement.

All our units are requested to reach to the employees (of any union) for garnering their support to the united movement with the slogan : <u>LET US ALL WORK TOGETHER FOR THE BENEFITS OF UNION BANK EMPLOYEES.</u>
